



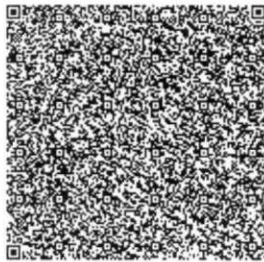

The Complainant, Info Edge (India) Limited, a company registered under the Indian Companies Act, 1999 having its registered office at Ground Floor, GF-12A, 94, Meghdoot, Nehru Place, New Delhi 110020 India filed a Complaint before .In Registry (NIXI) under .In Domain Name Dispute Resolution Policy challenging the registration of impugned domain name www.99acres.co.in by the Respondent, Mr. Sahil Lama, 63, Blaxland Street, Hunters Hill, Sydney, New South Wales 2110 Australia.
2. The disputed domain name <www.99acres.co.in> has been registered by the Respondent with the Registrar



GoDaddy.com, LLC 14455, N. Hayden Rd., Ste. 226  
Scottsdale, AZ 85260 USA.

3. The Complaint as filed with the .In Registry, National Internet Exchange of India (NIXI), against the Respondent was verified by NIXI and was found to have met the formal requirements of the .in Domain Name Dispute Resolution Policy ("The Policy") and the Rules of Procedure ("The Rules").
4. The Panel submitted the Statement of Acceptance and Declaration of Impartiality and Independence, as required by NIXI to ensure compliance with the Rules (paragraph-6).
5. In accordance with the Rules, Paragraph-2(a) and 4(a), NIXI formally notified the Respondent of the Complaint and appointed me as a Sole Arbitrator for adjudicating upon the dispute in accordance with The Arbitration and Conciliation Act, 1996, Rules framed there under, .In Dispute Resolution Policy and Rules framed there under and the parties were notified about my appointment as an Arbitrator on April 21, 2015.
6. By my email dated 24.04.2015, the complainant was directed to transmit soft copy of the complaint as well as the annexures to the Respondent at its registered email ID as appearing in WHOIS record of the disputed domain name. Simultaneously, I also sought proof of the delivery of the complaint as well as all the annexures to the respondent from .In Registry.



7. NIXI, by its email of April 27, 2015 informed me that hard copy of the complaint along with Annexures were sent to the respondent on 23.04.2015 by Courier and copy of the Courier consignment receipt was also provided.
8. The Respondent was duly served with the soft as well as hard copy of the Complaint and the Annexures thereto.
9. The Respondent on being served, expressed his willingness to transfer the disputed Domain Name to the Complainant subject to the reimbursement of the administrative charges incurred by him for the registration and maintenance thereof by his e-mail dated 26<sup>th</sup> April, 2015. Thereafter, parties exchanged correspondence and arrived at an amicable settlement. In pursuance of the said settlement, the Respondent was paid the administrative/maintenance charges by the Complainant and the Respondent by his e-mail dated 5<sup>th</sup> May, 2015 requested the Registrar to transfer the disputed Domain to the Complainant.
10. In view of the fact that the dispute has amicably been settled between the parties, the settlement is taken on record and an Award is passed in terms thereof. In the circumstances, I do not consider it necessary to go into the merits of the case in the present Arbitration proceedings.



11. I, therefore, direct that the Domain Name

Complainant.
