



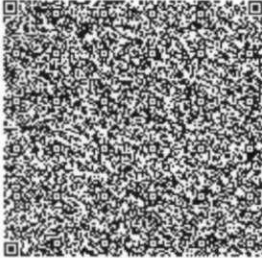

AWARD:


The present dispute relates to the registration of the domain name www.rajnigandha.in in favour of the Respondent.

The Complainant has filed the instant complaint challenging the registration of the domain name < www.rajnigandha.in > in favour of the Respondent. Pursuant to the In Domain Name Dispute Resolution Policy (INDRP) and the rules framed there-under, the Complainant had preferred this arbitration for raising this dispute for redressal of its grievances.

In its complaint, the Complainant has stated that the brand name, "Rajnigandha" rules the market as the world's largest selling premium pan masala and is also the flagship brand of DS(Dharma Satya pal Ltd.) that the complainant is among the top industrial houses in India and is the largest manufacturer of the tobacco and Non tobacco scented products in the country. The complainant considers their trade/ service name/ mark an extremely valuable asset and thus in order to protect the same has secured trademark registration for the mark "Rajnigandha" GLOBALLY INCLUDING India. The DS group has consolidated its position into diversified sectors like food and beverages, packaging, hospitality, rubber thread, cement and other businesses.

That the complainant has further stated that the present official website www.rajnigandha.com is redirected to www.dsgroup.com which is their flagship company, disclosing a comprehensive unique and acclaimed introduction to Rajnigandha.

After I entered reference on 14th May 2012 and both the parties filing their respective pleadings. I have received a written intimation dated 25.07.2012 from the ANM Global Inc.(Solicitors and advocates) counsel representing




the complainant whereby the said counsel has intimated that the complainant wants to withdraw the instant complaint without any prejudice to any of the complainant's intellectual property rights and permission to file any further suits in any of the legal forums, courts and tribunals and take any appropriate legal recourse as and when required.

Considering the facts and circumstances of the present matter and taking view of the precedents in this context it would be fit to allow the complaint to withdraw the same without prejudice to the rights and liabilities of the parties.

The said complaint is therefore dismissed as withdrawn.
