III. APPLICABLE LAW AND JURISDICTION

The present arbitration proceeding is under and in accordance with the .IN Domain Name Dispute Policy (*hereinafter referred as “the Policy”*), which was adopted by the National Internet Exchange of India (NIXI) and sets out the legal framework for resolution of disputes between a domain name registrant and a Complainant arising out of the registration and use of an .IN Domain Name. In the present case, by registering the domain name <amriksukhdev.in> with the NIXI-accredited Registrar, the Respondent has agreed to the resolution of disputes under the .IN Dispute Resolution Policy and Rules framed thereunder. The Policy and the .IN Domain Name Dispute Resolution Rules of Procedure (*the Rules*) were approved by NIXI in accordance with the Arbitration and Conciliation Act.1996.

IV. PROCEDURAL HISTORY

1. The Complainant filed the Complaint with NIXI against the Respondent regarding the disputed Domain Name <amriksukhdev.in>.
2. Mr. Manish Paliwal submitted the Statement of Acceptance and Declaration of Impartiality and Independence, as required by NIXI, on 29.06.2026.

3. Subsequently, the Sole Arbitrator was appointed on 21.07.2026 by NIXI for the adjudication of the present case, i.e. INDRP case No. 2150, regarding the disputed Domain Name <amriksukhdev.in>
4. The present Arbitral Proceedings have commenced on 23.07.2026, by issuing Notice under 5(c) of the INDRP Rules of Procedure and the same was sent through email to the Respondent as well as the Complainant, directing the Complainant to serve copies of the domain complaint along with complete set of documents in soft copies as well as in physical via courier or post to the Respondent Registrant and was further directed to file affidavit of service along with proof of service and proof of delivery of the said courier/post. Further, the Respondent was directed to file its Reply/Response to the Complaint within fifteen (15) days from the date of this Notice, i.e., on or before 06.08.2026.
5. Vide email dated 24.07.2026, Mr. Subhash Bhutoria, attorney for the Complainant, addressed this Arbitral Tribunal by submitting that the Respondent Registrant had acknowledged receipt of the Complaint and the accompanying documents vide email dated 22.07.2026.
6. This Arbitral Tribunal, vide email dated 27.07.2026 directed to the Complainant to effect service of the hard copy and furnish proof of service of soft and hard copies within seven (7)days from 27.07.2026 and further directed to file Service Affidavit.
7. The Respondent submitted his response on 03.08.2026. Further, the Respondent submitted that he has approached the Complainant for a possible transfer and an amicable settlement to resolve the dispute without prolonged proceedings.
8. Vide communications dated 09.09.2026 and 12.09.2026, both parties shared their communications regarding the mutually agreed settlement with the Sole Arbitrator.

9. The Respondent vide email dated 15.09.2026, confirmed the mutual settlement between both parties.

10. Vide communication dated 16.09.2026, the Complainant shared the mutually agreed settlement terms with the Sole Arbitrator.

V. FINDINGS:

In view to amicably resolve the dispute, both the Complainant as well as the Respondent agreed to a Settlement, with the following terms & conditions:

1. *"The Respondent hereby acknowledges and confirms that the Complainant is the rightful owner of the trademark and well-known brand, AMRIK SUKHDEV, and further acknowledges the Complainant's exclusive rights, title, interest, goodwill and reputation therein. The Respondent hereby undertakes that it shall not, directly or indirectly, challenge, dispute, oppose or question the Complainant's rights, title and interest in and to the trademark AMRIK SUKHDEV, in any manner, whatsoever.*
2. *The Respondent acknowledges that it has no right or legitimate interest in the trademark, Amrik Sukhdev. The Respondent further undertakes that it shall not adopt, use, register, apply for registration of, advertise, market, promote or otherwise deal with any mark or expression which is identical with or deceptively similar to AMRIK SUKHDEV, calculated to create an association with the Complainant or its trademark.*
3. *The Respondent hereby irrevocably undertakes to transfer the Impugned Domain Name, namely amriksukhdev.in, in favour of the Complainant, **within Two working days** from the date of execution of this settlement understanding / passing of arbitral award. The Respondent shall take all necessary steps and execute all documents, authorizations and forms required for effecting the transfer of the Impugned Domain Name in favour of the Complainant and shall extend full cooperation to the Complainant, the concerned Registrar and/or NIXI for completing the transfer.*
4. *The Respondent further undertakes that it shall permanently cease and desist from using the Complainant's trademark AMRIK SUKHDEV in any website, social media account, social media handle, online directory, business listing, advertisement, promotional material, metadata, keyword, search-engine*

optimization material or any other digital platform. The Respondent confirms that he has, either directly or indirectly, registered any other domain name, social media account et al. under any identical or deceptively similar name / mark and further undertakes that it shall not register, acquire or use any other domain name or social media account, incorporating the trademark AMRIK SUKHDEV, or any mark which is identical with or deceptively similar thereto.

5. *Subject to the Respondent's strict, complete and continuing compliance with the aforesaid terms, including the transfer of the Impugned Domain Name in favour of the Complainant, the Complainant agrees to forgo such other reliefs including costs and damages, as may have been sought in the present INDRP proceedings, save and except the right to enforce the present settlement and to take appropriate action in respect of any subsequent or continuing unauthorized use of the Complainant's Intellectual Property."*

VI. DISPOSITION/SUMMARY OF THE AWARD

In view of the abovementioned mutually agreed terms and conditions of the Settlement between the Complainant and the Respondent, the Arbitral Tribunal holds that the Respondent confirms the Complainant's rightful ownership and exclusive rights, title, interest, goodwill and reputation therein of the trademark AMRIK SUKHDEV. Further the Respondent undertakes not to adopt, use, register, apply for registration of, advertise, market, promote or deal with any mark or expression which is identical with or deceptively similar to AMRIK SUKHDEV. In addition, the Respondent undertakes to transfer the disputed Domain name in favour of the Complainant and to cease and desist from using the said trademark.

I, **MANISH PALIWAL**, the Sole Arbitrator, in view of the Settlement between the parties, do hereby publish award in accordance with the INDRP Rules of Procedure and .IN Domain Name Dispute

Resolution Policy (INDRP) and The Arbitration And Conciliation Act,1996, as follows:

The Arbitral Tribunal orders that the disputed domain name <amriksukhdev.in> be forthwith transferred from the Respondent to Complainant in accordance with the abovesaid terms and conditions of the mutual agreed **Settlement** between the parties. In view of the facts and circumstances of the present case and **Clause 5 of the Settlement** between the parties and having regard to the Complainant's prayer for costs in Paragraph 6(ii) of the Complaint, the Arbitral Tribunal makes no order as to costs.
