DOMAIN IN ISSUE: CAREERSIBM.CO.IN

ARBITRATION AWARD: (INDRP CASE NO.2169)

The Complainant, details as mentioned above in the title, has filed a Complaint under INDRP Policy and Rules of Procedure against the domain CAREERSIBM.CO.IN along with the relevant documents in its support.

The domain CAREERSIBM.CO.IN is registered in the name of the Respondent, as mentioned in the title above, through the Registrar GoDaddy.com, LLC 14455 N HAYDEN, Rd Suite 219, Scottsdale, Arizona 85260, USA. As per the information and details provided, the Domain CAREERSIBM.CO.IN was created and registered in the name of the Respondent.

After the filing of the domain Complaint, National Internet Exchange of India (referred to as NIXI) appointed me as an Independent Arbitrator as per the INDRP Policy and Rules of Procedure on 16 September, 2026 by an e-mail. The Statement of Acceptance and Declaration of Impartiality was accordingly sent to NIXI. Thereafter, an e-mail pertaining to the appointment as an Independent Arbitrator as well as commencement of the proceedings was sent by me to all parties concerned on 16 September, 2026 with direction to the Complainant to serve copies of the Domain Complaint and documents on the Respondent by prescribed modes.

Subsequently, the Respondent, upon receiving the e-mail dated 16 September, 2026 from the Arbitrator had sent an e-mail dated 17 September, 2026 (e-mail copy enclosed), whereby disclosing her consent to transfer/withdraw the domain in the Complainant's favour. As the Respondent has already given her consent to transfer the domain, the Domain complaint matter is decided on that basis itself without going into the merits of the case.

DECISION

On the basis of the above, it is hereby ordered that the domain CAREERSIBM.CO.IN be transferred to the Complainant. Parties are to bear their own Costs.
