

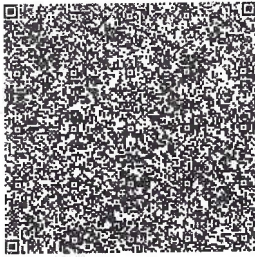

AWARD


The present dispute relates to the registration of the domain name flipkartsmartbuy.in in favour of the Respondent.

The Complainant has filed the instant complaint challenging the registration of the domain name < flipkartsmartbuy.in > in favour of the Respondents No. 2. In pursuance to Rule 3 of the In Domain Name Dispute Resolution Policy (INDRP) and the rules framed there under, the Complainant had preferred this arbitration for raising this dispute for redressal of its grievances.

I entered upon reference regarding the instant dispute and issued a notice dated 06.01.2018 by me to both the respondents calling upon for its response to the complaint filed by the complainant. After the respondents received the said notice, on 17.01.2018, Respondent No. 2 agreed to release the disputed domain name ie flipkartsmartbuy.in and requested that on release of the said disputed domain name, the Registrant relinquishes all right, claims and liabilities arising out of the domain name.

In view of the Communication dated 17.01.2018 given by the Respondent No. 2, I deem it fit and proper to allow the prayer of the Complainant in its favour and the registry is directed to transfer the said domain name i.e. < flipkartsmartbuy.in > in favour of the complainant.
