The joint request of the Respondent and Complainant for settling the dispute amicably by way of a compromise was allowed by this Tribunal subject to the condition that the

compromise settled be filed before this Tribunal on or before 29.03.2022.

Today on 29.03.2022 the compromise between the Complainant and the Respondent is placed before this Hon'ble Tribunal, which is taken on record and is made a part of this order as ANNEXURE 'A'

In terms of the compromise/settlement the Respondent has agreed to transfer the disputed domain name in favour of the Complainant.

Considering the terms of the compromise/settlement this Tribunal is of a view that the Complaint deserves to be allowed in favour of the Complainant and accordingly the Complainant is entitled to get the disputed domain name transferred in its favour.

IT IS ORDERED

- a) The Joint intimation of settlement is allowed to its terms.
- b) It is, directed that the domain name www.sonyservicecentre.in be transferred in favour of the Complainant by the Registry, as a result, the Respondent,



his agents, servants, dealers, distributors and any other person(s) acting for and on its behalf are permanently restrained from using the domain name www.sonyservicecentre.in or any other deceptively similar trademark, which may amount to infringement of Complainant registered trademark and also from doing any other thing, which is likely to create confusion and deception with the goods/services of the Respondent for any connection with the Complainant.

c) National Internet Exchange of India (NIXI) is advised to take incidental or ancillary action involved in the transfer of the domain name, as directed.
